Arkade Developers Ltd reports robust financial performance with 35.2% rise in Net Profit to Rs. 73.58 Cr for H1 FY25

Q2 & H1 FY25 Results Highlights

- H1 FY25 Revenue rose 20.4% to ₹ 328.85 Cr
- H1 FY25 EBITDA jumped 36.9% to ₹ 102.49 Cr
- H1 FY25 Collections rose 26.9% to ₹ 299.95 Cr
- H1 FY25 Pre-sales at ₹ 336.44 Cr

<u>Mumbai, November 13th, 2024</u>: Arkade Developers Limited amongst the leading real estate development companies in Mumbai, reported revenue growth of 20.4% year-on-year at ₹ 328.85 Cr for the first half year ended September 30, 2024. Net profit for the first half rose 35.2% to ₹ 73.58 Cr; while Earnings Before Interest, Tax, Depreciation and Amortisation (EBITDA) jumped 36.9% to ₹ 102.49 Cr.

For the second quarter, the Company reported revenue of ₹ 203.34 Cr. Net Profit and EBITDA for the quarter stood at ₹ 43.36 Cr and ₹ 60.41 Cr. The strong revenue growth for the first half came from robust trajectory of pre-sales achieved over last few quarters, the revenue recognition of which was done in H1FY25.
