"RESOLVED THAT pursuant to the provisions of Section 62(1)(b) of the Companies Act, 2013 read with Rule 12 of the Companies (Share Capital and Debenture) Rules, 2014 and provisions of the SEBI (Share Based Employee Benefits and Sweat Equity) Regulations, 2021 (SEBI SBEB Regulations) and SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015, as recommended by the Nomination and Remuneration Committee and approval of the Board of Directors of the Company ("**Board**") vide resolution dated May 27, 2026, the relevant provisions of the Memorandum of Association and the Articles of Association of the Company and subject to the approval of Stock Exchanges where the shares of the company are listed and such other approvals, permissions and sanctions as may be necessary and subject to such conditions and modifications as may be prescribed or imposed while granting such approvals, permissions and sanctions, the consent of the members of the Company be and is hereby accorded to approve the '**Arkade Employees Stock Option Plan 2026**' hereinafter referred to as the "**ARKADE ESOP 2026**" as aligned with the provision

The Ministry of Corporate Affairs ('MCA'), vide its General Circular No. 20/2020 dated May 05, 2020 read with the subsequent circulars issued from time to time, the latest one being General Circular No. 03/2025 dated September 22, 2025 (MCA Circulars) has permitted to hold the AGM through VC/OAVM in accordance with the requirements laid down in Para 3 and Para 4 of the General Circular No. 20/2020 dated May 05, 2020 and accordingly the 40th AGM of the Company is being conducted through VC/OAVM. The deemed venue of the AGM shall be the registered office of the Company at Arkade House, Ashok Nagar, Kandivali East, Mumbai-400101.
2. Pursuant to the MCA Circular No. 14/2020 dated April 08, 2020 and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (the Listing Regulations), the facility to appoint proxy to attend and cast vote for the members is not available for this AGM, since this AGM is being held through VC/OAVM and therefore requirement of Proxy Form, Attendance Slip and Route Map are not annexed to this AGM notice. However, in pursuance of Section 112 and Section 113 of the Companies Act, 2013 (the Act), representatives of the members such as the President of India or the Governor of a State or body corporate can attend the AGM through VC/OAVM and cast their votes through e-voting.
3. Pursuant to the provisions of Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended), Regulation 44 of the Listing Regulations (as amended) and MCA Circulars, the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM. For this purpose, the Company has engaged the services of Bigshare Services Private Limited for facilitating voting through electronic means, as the authorised e-Voting's agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the AGM will be provided by Bigshare Services private Limited viz <https://www.ivote.bigshareonline.com>.
4. The Explanatory Statement pursuant to Section 102 of the Act in respect of the business under Item Nos 4, 5 & 6 set out above and the relevant details in respect of the Directors seeking appointment/ re-appointment at this AGM as required under Regulation 36(3) of the Listing Regulations and Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India ('Secretarial Standard') are annexed hereto. Requisite declarations have been received from the Directors seeking appointment/re-appointment.
5. Institutional Members/Corporate Members (i.e. other than individuals, HUFs, NRIs, etc.) are required to send a scanned copy (PDF/JPG format) of their respective Board or governing body Resolution, Authorization, etc., authorizing their representative to attend the AGM through VC/OAVM on their behalf and to vote through remote e-Voting. The said Resolution/ Authorization shall be sent to the Scrutinizer by e-mail to vijay.yadav@avsassociates.co.in and ivote@bigshareonline.com. Institutional Members/Corporate Members can also upload their Board Resolution/ Power of Attorney/Authority Letter, by clicking on "Upload Board Resolution/Authority letter", etc. displayed under 'e-Voting' tab in their Login.
6. The Members can join the AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC/OAVM will be made available to at least 1,000 Members on a first come first served basis as per the MCA Circulars. This will not include large shareholders (shareholders holding 2% or more shareholding), Promoter/ Promoter Group, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the AGM without restriction on account of first come first served basis. 7. Members attending the AGM through VC/OAVM shall be counted for the purpose of reckoning the quorum under Section 103 of the Act.
8. Only registered Members of the Company may attend and vote at the AGM through VC/OAVM facility.

Members are also advised to not leave their demat account(s) dormant for long. Periodic statement of holdings should be obtained from the concerned DP and holding should be verified from time to time.
15. Non-Resident Indian Members are requested to inform the Company's RTA immediately of:
 - a) Change in their residential status on return to India for permanent settlement
 - b) Particulars of their bank account maintained in India with complete name, branch, account type, account number and address of the bank with pin code number, if not furnished earlier.

18. Members/Claimants who have not yet encashed their dividend(s) are therefore requested to claim the same from the Company within the stipulated period. Members are also advised to ensure that their bank account details and other relevant particulars are updated with the Company/Registrar and Transfer Agent, as applicable, to facilitate timely receipt of dividends.
19. To support the 'Green Initiative', Members who have not yet registered their email addresses are requested to register the same with their DPs in case the shares are held by them in electronic form.
20. Shareholders who would like to express their views/ ask questions during the meeting may register themselves as a speaker by sending their request from their registered e-mail address mentioning their name, demat account no., e-mail address and mobile no. at cs@arkade.in on or before **Friday, September 11, 2026 (05.00 p.m.)**. The Company reserves the right to restrict the number of speakers depending on the availability of time for the AGM.
21. Those Shareholders who have registered themselves as a speaker will only be allowed to express their views/ ask questions during the meeting. Relevancy of the question and the order of speakers will be decided by the Chairman.
22. **Voting by Members**
 - a) A person, whose name is recorded in the Register of Members or in the Register of Beneficial Owners maintained by the depositories as on **Tuesday, September 15, 2026 ('cut-off date')** shall be entitled to vote in respect of the shares held, by availing the facility of remote e-voting prior to the AGM or remote e-voting during the AGM.

The remote e-Voting period commences on **Friday, September 18, 2026 at 09.00 a.m. (IST)** and ends on **Monday, September 21, 2026 at 05.00 p.m. (IST)**. The remote e-Voting module shall be disabled by Bigshare for voting thereafter. Once the vote on a resolution is cast by the Member, the Member shall not be allowed to change it subsequently.
 - b) The Members can opt for only one mode of remote e-voting i.e. either prior to the AGM or during the AGM. The Members present at the Meeting through VC/OAVM who have not already cast their vote by remote e-voting prior to the Meeting shall be able to exercise their right

to cast their vote by remote e-voting during the Meeting. The Members who have cast their vote by remote e-voting prior to the AGM are eligible to attend the Meeting but shall not be entitled to cast their vote again.

EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013

Item No. 4

Pursuant to Section 148 of the Act read with the Companies (Audit and Auditors) Rules, 2014, as amended from time to time, the Company is required to audit its cost accounts relating to such products manufactured by the Company covered under the Central Excise Tariff Act, 1985, as prescribed under Section 148 of the Act and the Companies (Cost Records and Audit) Rules, 2014, conducted by a Cost Accountant. Based on the recommendation of the Audit Committee, the Board had, at its meeting held on May 27, 2026, approved the appointment of M/s Joshi Apte & Associates Cost Accountants (Firm Registration No. 000240) as the Cost Auditors of the Company to conduct audit of cost records maintained by the Company, for FY 2026-27 at a remuneration of Rs. 82,600/- (Rupees Eighty Two Thousand Six Hundred Only) including taxes, out-of-pocket and other expenses.

In accordance with the provisions of Section 148 of the Act read with Rule 14 of the Companies (Audit and Auditors) Rules, 2014, as amended from time to time, ratification for the remuneration payable to the Cost Auditors to audit the cost records of the Company for the said financial year by way of an Ordinary Resolution is being sought from the Members as set out at Item No. 4 of the accompanying Notice. M/s Joshi Apte & Associates have furnished a certificate dated April 16, 2026 regarding their eligibility for appointment as Cost Auditors of the Company. They have vast experience in the field of cost audit. The Board recommends the Ordinary Resolution set out at Item No. 4 of the accompanying Notice for approval by the Members.

None of the Directors, Key Managerial Personnel of the Company or their relatives are, in any way, concerned or interested, financially or otherwise, in the said Resolution.

Item No. 5 & 6

Employee stock options are internationally recognized as an effective mechanism for attracting, retaining, rewarding, and motivating talented employees. They align the interests of employees with those of the Company and its shareholders by providing an opportunity to participate in the Company's future growth and value creation. Such ownership-oriented incentives foster long-term commitment, enhance employee engagement and productivity, and encourage a shared focus on achieving sustainable growth, profitability, and maximization of shareholder value.

In the present competitive economic environment in the country and in the long-term interests of the Company and its shareholders, it is necessary that the Company adopts suitable measures for attracting and retaining qualified, talented and competent personnel.

An employee stock option scheme, designed to foster a sense of ownership and belonging amongst personnel, is a well-accepted approach to this end. It is, therefore, appropriate

to consider an Employee Stock Option Scheme for the employees of the Company and subsidiary company(ies).

The Board of Directors, on the recommendation of the Nomination and Remuneration Committee, has approved the "Arkade Employee Stock Option Plan 2026" (hereinafter referred to as Arkade ESOP 2026) at its meeting held on May 27, 2026, subject to the approval of the shareholders.

Further, the Board on the recommendation of the Nomination and Remuneration Committee has approved the extending of the benefits of the said scheme to the present and future employees of existing and/or future Subsidiary(ies) of the Company situated in India and overseas, and its director(s), whether Whole-time Director or not, but excluding Independent Directors.

Disclosure/main features of Arkade ESOP 2026 pursuant to the Companies Act, 2013 and the SEBI SBEB Regulations are as under:

a) Brief description of the Scheme:

The Scheme shall be called as "**Arkade Employee Stock Option Plan 2026**" (hereinafter referred to as Arkade ESOP 2026).

The Scheme contemplates grant of Stock Options to the employees (which includes eligible Directors) of the Company and those of the subsidiary(ies) of the Company (present and future, if any).

The objectives of the Scheme are:

- To provide means to enable the Company to attract and retain appropriate human talent;
- To motivate the employees with incentives and reward opportunities;
- To achieve sustained growth of the Company and the creation of shareholder value by aligning the interests of the employees which will lead to long-term wealth creation; and

After vesting of Stock Options, the employees earn a right, but not an obligation, to exercise the vested Stock Options within the exercise period and obtain equity shares of the Company which shall be issued by the Company subject to payment of exercise price and satisfaction of any tax obligation arising thereon and other terms and condition of the Scheme.

b) Total number of stock options to be offered and granted:

The total number of stock options granted under the Plan shall not exceed **2,00,000 (Two Lakhs only)**

Shares of the Company, in aggregate shall not exceed **0.11 %** of the issued equity share capital (excluding outstanding warrants and conversions, if any) of the Company at the time of grant of Option, unless otherwise determined by the Board / the Committee.

In case of any corporate action(s) such as rights issue, bonus issue, merger, demerger, sale of division, expansion of capital, change in capital structure and others, if any including preferential allotment of shares or qualified **institutional** placement, additional Stock Options of the Company are to be issued to the Employees for the purpose of making a fair and reasonable adjustment to the Stock Options issued to them, the above ceiling in terms of number of equity shares shall be deemed to be increased in proportion to the additional equity shares issued in the aforesaid corporate action(s).

c) Identification of classes of Employees entitled to participate in the Scheme:

As decided by the management on a case-by-case basis, eligibility will be determined by their qualifications or past performance, contribution to the company's growth, and the criticality of the position held within the company, and such other conditions as may be decided by the Board/Committee in this regard. This shall apply in case of employees of the subsidiary(ies) of the Company (present and future, if any).

d) Requirements of vesting and period of vesting:

The options granted to eligible employee shall vest within the vesting period in the manner as set forth in the Letter of Grant. The minimum vesting period shall be 1 year from the date of grant. The maximum vesting period under the Plan should not exceed 5 years from the date of grant.

Unless the Board decides otherwise, the below mentioned vesting schedule shall be followed by the Company:

Year 1	10% of the Options Granted
Year 2	20% of the Options Granted
Year 3	30% of the Options Granted
Year 4	40% of the Options Granted

The Board at its discretion may grant Option specifying Vesting Period ranging from minimum and maximum period as afore-stated or any other vesting schedule as per the case and as the board deems fit

e) Maximum period (subject to regulation 18(1) and 24(1) of these regulations, as the case may be) within which the options / SARs / benefits shall be vested:

All the options granted on any date shall vest not later than 5 (five) years from the date of grant of options subject to conditions, if any, mentioned in the Letter of Grant.

f) Exercise price:

Exercise Price means the price payable by an Option Grantee in order to Exercise the Options granted to him/her in pursuance of the ARKADE ESOP 2026. The Exercise Price per Option shall be determined by the Board which shall not be lesser than the face value of the Share as on date of Grant of such Option. The specific Exercise Price shall be intimated to the Option Grantee in the Grant Letter at the time of Grant.

g) Exercise period and the process of exercise:

The Exercise Period shall be 1 (One) years from the date of respective vesting of options.

The employee can exercise options at any time after the vesting date either in full or in tranches by making full payment of exercise price and applicable taxes and by execution of such documents as may be prescribed by the Board/ Committee, from time to time.

All unexercised options that so lapse, shall brought back/revert to the Arkade ESOP 2026 pool and may be granted at the discretion of the Board/ Committee to any other eligible employee. The detailed terms and conditions of exercise period is mentioned in the Scheme.

h) The appraisal process for determining the eligibility of the Employees for the Scheme:

Appraisal process for determining the eligibility of the Employees will be based on designation, period of service, performance linked parameters such as work performance and such other criteria as may be determined by the Board/Committee at its sole discretion, from time to time.

i) Maximum number of options to be offered per Employee and in aggregate under the Scheme:

The maximum number of Options under ARKADE ESOP 2026 that may be granted to any identified Employee in any year shall in aggregate **not exceed 0.11 %** of the issued equity share capital (excluding outstanding warrants and conversions, if any) of the Company at the time of grant of Option.

j) Maximum quantum of benefits to be provided per Employee under the Scheme:

The maximum quantum of benefits underlying the options issued to an employee shall be equal to the difference between the option exercise price and the market price of the shares on the exercise date, as stated under (h) read with (b) above.

k) Whether the Scheme is to be implemented and administered directly by the Company or through a trust:

The Arkade ESOP 2026 is to be implemented and administered directly by the Company, through the Board/ Committee.

- l) **Whether the Scheme involves new issue of shares by the Company or secondary acquisition by the trust or both:**

The Arkade ESOP 2026 involves only new issue of shares by the Company.

- m) **The amount of loan to be provided for implementation of the Scheme(s) by the Company to the Trust, its tenure, utilization, repayment terms, etc.:**

Not Applicable, as Arkade ESOP 2026 is proposed to be implemented directly by the Company.

- n) **Maximum percentage of secondary acquisition that can be made by the Trust for the purpose of the Scheme:**

Not Applicable, as Arkade ESOP 2026 involves only new issue of shares by the Company.

- o) **A statement to the effect that the company shall conform to the accounting policies specified in regulation 15:**

The Company shall comply with the disclosures and accounting policies prescribed in SEBI SBEB Regulations and any other authorities as applicable, from time to time.

- p) **The method which the company shall use to value its options:**

The Company shall use fair value method for valuation of the options as prescribed under the Indian Accounting Standards, as applicable and notified by appropriate authorities from time to time.

- q) **Declaration (if applicable):**

Not Applicable

- r) **Period of lock-in:**

The Shares issued upon Exercise of Vested Options shall be freely transferable and shall not be subject to any lock-in period restriction after such Exercise.

The Board/Committee shall be entitled to formulate the detailed terms and conditions of the Arkade ESOP 2026 from time to time in relation to the procedure for buy-back of specified securities under the SEBI SBEB Regulations, if to be undertaken at any time by the Company, and the applicable terms and conditions, including:

- (i) Permissible sources of financing for buy-back;
- (ii) Any minimum financial thresholds to be maintained by the Company as per its last financial statements; and
- (iii) Limits upon quantum of specified securities that the Company may buy-back in a financial year.

As per the provisions of Regulation 6(1) of the SEBI SBEB Regulations, every share-based incentive scheme is required to be approved by the Members of a Company by way of a Special Resolution. In addition, as per the provisions of Section 62(1)(b) of the Act and the rules made thereunder, consent of the Members by way of a Special Resolution is required for issuance of shares under employee stock option schemes.

Further, pursuant to regulation 6(3) of the SEBI SBEB Regulations, to grant options to the employees of the subsidiaries of the Company, is required to be approved by the Members of a Company by way of a Special Resolution.
